



## St. Bruno School 2021/2022 Tuition and Fees

**Registration Fee (Non Refundable) - \$100 per family** due with completed & signed Contract by April 16, 2021. After April 16, 2021 we cannot guarantee your child's spot in their class. *(\$75 per family registration fee, if registered in office and with FACTS before March 26, 2021)*

**FACTS FEE: Registration Fee (Non Refundable) \$40 per family** for a monthly FACTS account. This will be paid with your first monthly payment.

**Mandatory Tuition Raffle Fee - TOTAL = \$220 per family**

- **\$220 Tuition Raffle fee** fulfilled by purchasing raffle tickets by August 23, 2021

**Mandatory Instructional Fee - TOTAL= \$250 per student**

- **\$250 instructional fee** which will be divided up and added to your monthly tuition payments on FACTS

### Service Hours

- Service hours do not count towards your fees
- Each family must work 20 service hours total
  - 10 service hours of which are mandatory to be completed at St. Bruno Bingo
  - 10 service hours of which can be completed at other St. Bruno events
- Hours may be worked from April 1, 2021 through March 31, 2022.
- If 20 hours are not worked, a family's account will be charged \$20 per hour for unfulfilled service hours on April 1, 2022

### Exclusion Policy for the 2021 – 2022 School Year

- If payment for raffle tickets is not made by August 23, 2021 your child will not be able to start school until tickets are purchased. Tickets must be paid in full before your child starts school.
- When you sign this contract you are agreeing to pay the amount of tuition due each month. If after being contacted by FACTS and St. Bruno School, your tuition payments are not current your child(ren) will be held out of school. The exclusion dates for the 2021-2022 school year are as follows:

- August 30, 2021
- November 1, 2021
- January 10, 2022
- March 7, 2022
- May 2, 2022

5. I understand that I must pay a non refundable registration fee for the FACTS account.
6. I must work 20 service hours total (10 of which are mandatory to be worked at Bingo, and the other 10 service hours to be completed at St. Bruno events) or be charged through my account \$20 per unfulfilled service hours.
7. I must sign and return this Agreement with a \$100 non – refundable per family Registration Fee by April 16, 2021. (\$75 per family registration fee if registered in office and with FACTS before March 26, 2021)
